Packed in paper, plastic, raffia and foil bags, big-bag, bag in carton box, plastic and metallic jar. Blending, filtering and packing of capsicum oleoresins plastic drums. Packing of food colouring in plastic bags and jar. Outsourced process of milling and blending, reducing microbial charge, smoking process and packing.
