Production (blending and filtering) and packing of sweet and hot Capsicum oleoresins packed in plastic drums.  
Packing of food colouring in plastic bags and jar.

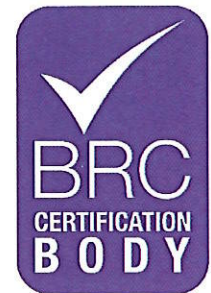

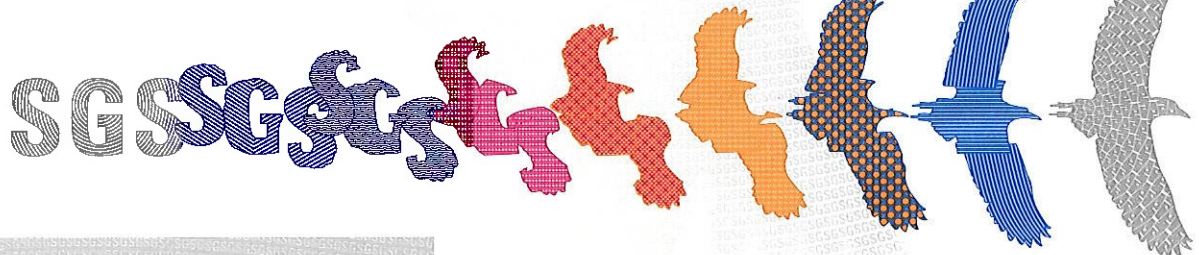
